## SEETO COMREHENSIVE NETWORK

- PRIORITY INVESTMENTS WILL SERVE TO STRENGTHEN TRANSPORT NETWORK IN THE WESTERN BALKAN REGION
- THE ULTIMATE AIM OF THE REGION IS TO DEVELOP AN EFFICIENT, INTEROPERABLE AND INTEGRATED MULTI-MODAL TRANSPORT SYSTEM
- TRANSPORT PLANNING WHICH GOES BEYOND THE NATIONAL PRIORITIES
- POLICY LEADING TOWARD CREATION OF SEETO CORE NETWORK WHICH WILL CORRESPOND TO TEN-T CORE NETWORK
- SUPPORT PROVIDED BY THE EUROPEAN COMMISSION (DGs INVOLVED) AND THROUGH COOPERATION WITH THE WESTERN BALKAN COMPLY WITH THE REQUIREMENTS OF THE EU ACQUIS AND THE COMMON TRANSPORT MARKET.

Route 6 A (259 km):Ribarevina (Montenegro) – Ribarice (Serbia) – Pristina (Kosovo under UNSCR 1244/99) –
Skopje (the former Yugoslav Republic of Macedonia)




## SEETO ROAD ROUTE 4 / BAR-BOLJARE MOTORWAY

#### **DESCRIPTION:**

- SEETO COMPREHENSIVE NETWORK ROAD ROUTE 4
- LINKING THE ADRIATIC COAST AT BAR VIA THE CAPITAL PODGORICA TO THE SERBIAN BORDER AT BOLJARE
- PLANNED TO CONNECT MONTENEGRO WITH REPUBLIC OF SERBIA THROUGH POZEGA –
   BELGRADE AND FURTHER LINK ON TEN-T CORRIDOR X, AND HENCE TO ROMANIA AND CENTRAL EUROPE
- IT WOULD ALSO CONNECT WITH ROUTES TO THE REGIONAL CAPITAL CITIES OF SARAJEVO IN BOSNIA AND HERZEGOVINA, TIRANA IN ALBANIA AND SKOPJE IN MACEDONIA THEREFORE BARBOLIARE MOTORWAY HAS A CLEAR STRATEGIC ROLE TO PLAY IN THE REGION.
- CORRIDOR: BAR DJURMANI TUNNEL SOZINA VIRPAZAR TANKI RT- FARMACI (PODGORICA)
   MAREZA (PODGORICA) SMOKOVAC (PODGORICA) BRATONOZICI VERUSA MATESEVO –
   ANDRIJEVICA BERANE BOLJARE
- APPROXIMATE LENGTH 170 KM
- 42 TUNNELS AND 101 BRIDGES, VIADUCTS (OVER 30% OF ALIGNMENT UNDER STRUCTURES)
- PART OF CORRIDOR- TUNNEL SOZINA WITH ACCESS ROADS, APPROX. LENGTH 12 KM

# SEETO ROAD ROUTE 4 / BAR-BOLJARE MOTORWAY PRIORITY SECTION SMOKOVAC-MATEŠEVO



- BOTTLENECK OF SEETO ROAD ROUTE 4
- CONSTRUCTION OF S-M SECTION WILL INSTANTLY IMPROVE THE LINK BETWEEN THE NORTH AND SOUTH OF MONTENEGRO
- WILL REDUCE REGIONAL INEQUALITIES
- WILL IMPROVE THE ATTRACTIVENESS OF THE INTERNATIONAL LINK TO PORT OF BAR AND MONTENEGRO COASTLINE
- WILL REMOVE AN ACCIDENT BLACKSPOT

## SEETO ROAD ROUTE 4 / BAR-BOLJARE MOTORWAY

- PROJECT IS A KEY ELEMENT IN OUR STRATEGY OF "ACCESSION" TO THE EU
  AS IT WILL ALLOW OUR COUNTRY TO BE FULLY INTEGRATED WITHIN
  EUROPE
- THE PROJECT IS ALSO VERY IMPORTANT FOR THE UNIFICATION OF THE COUNTRY AS IT WILL ALLOW THE NORTH-EAST REGIONS TO BE CONNECTED TO THE COAST THROUGH OUR CAPITAL
- THE PROJECT WILL ALLOW OUR KEY PORT OF BAR TO BE FULLY CONNECTED TO THE REST OF THE EUROPEAN CORRIDORS AND BETTER SERVE KOSOVO AND SERBIA, FURTHER FACILITATING THE UNLOCKING OF THIS PART OF THE WESTERN BALKANS AND CONTRIBUTING TO ECONOMIC AND POLITICAL STABILITY IN THE REGION
